Poor blood circulation, kidney stones, edema, and contracture are just a few of the problems associated with paralysis. The progression of ALS Lou Gehrig's Disease leads to paralysis, but range of motion ROM, motomed therapy, standing sessions, and exercise can prevent these problems and help maintain mobility for as long as possible. These therapies are provided in the patient's home. The average number therapy sessions per week for the year were 20, at one hour per session. Therefore, approximately 1,040 hours of therapy was provided at no cost to ALS patients.

Many of the Foundation's clients do not own wheelchair accessible transportation. The Foundation owns and maintains a wheelchair accessible van to transport ALS patients to doctor appointments, ALS clinic days, to high school graduations, family reunions, and trips to get out of the house. The van was used for 32 of these events for an average of 16 miles per event. Employee hours, gas, and maintenance are included in the cost of this service at no charge to the ALS patients.
